The relative strengths and weaknesses of PEABODY ENERGY CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PEABODY ENERGY CORP compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 55% points. The greatest weakness of PEABODY ENERGY CORP is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 53% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 105% points above the market average of -36%.
