The relative strengths and weaknesses of INTERNATIONAL TOWER HILL MINES LTD are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of INTERNATIONAL TOWER HILL MINES LTD compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 75% points. The greatest weakness of INTERNATIONAL TOWER HILL MINES LTD is the variable Other Revenues, reducing the Economic Capital Ratio by 20% points.

The company's Economic Capital Ratio, given in the ranking table, is 231%, being 267% points above the market average of -36%.
