## SUPERIOR INDUSTRIES INTERNATIONAL INC Rank 39 of 56

The relative strengths and weaknesses of SUPERIOR INDUSTRIES INTERNATIONAL INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SUPERIOR INDUSTRIES INTERNATIONAL INC compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 259% points. The greatest weakness of SUPERIOR INDUSTRIES INTERNATIONAL INC is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 544% points.

The company's Economic Capital Ratio, given in the ranking table, is -41%, being 50% points below the market average of 8.6%.
