The relative strengths and weaknesses of CHINA AUTOMOTIVE SYSTEMS INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of CHINA AUTOMOTIVE SYSTEMS INC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 309% points. The greatest weakness of CHINA AUTOMOTIVE SYSTEMS INC is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 247% points.

The company's Economic Capital Ratio, given in the ranking table, is 136%, being 249% points above the market average of -113%.
