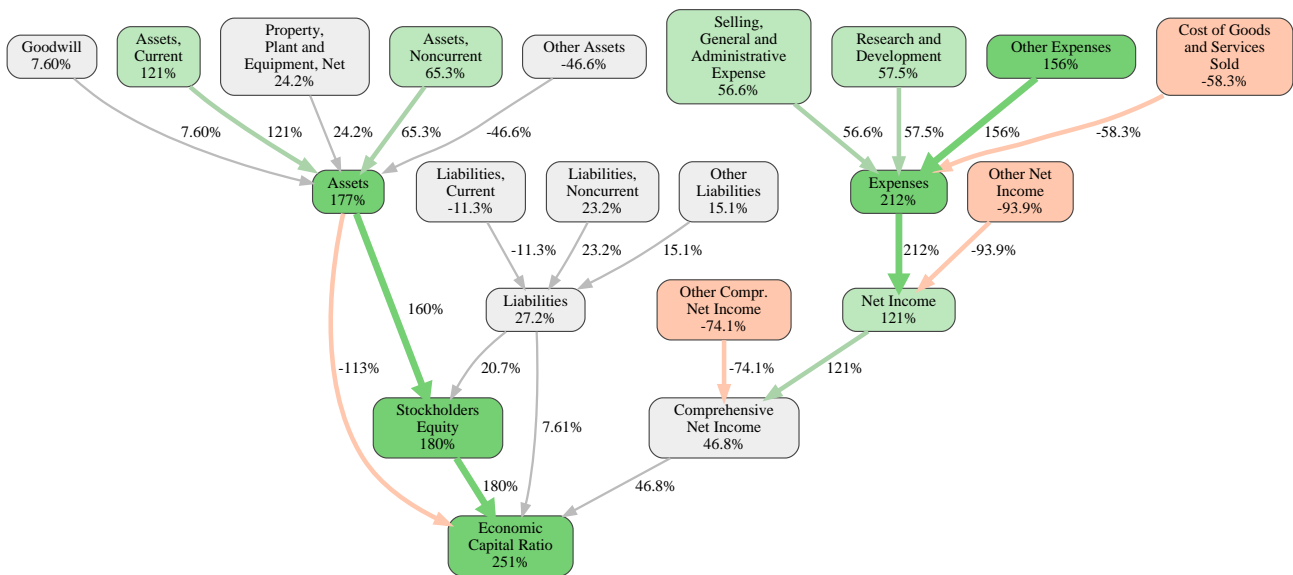

The relative strengths and weaknesses of Kandi Technologies Group Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kandi Technologies Group Inc. compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 212% points. The greatest weakness of Kandi Technologies Group Inc. is the variable Other Net Income, reducing the Economic Capital Ratio by 94% points.

The company's Economic Capital Ratio, given in the ranking table, is 138%, being 251% points above the market average of -113%.
