The relative strengths and weaknesses of Gulfslope Energy INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gulfslope Energy INC compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 110% points. The greatest weakness of Gulfslope Energy INC is the variable Net Income, reducing the Economic Capital Ratio by 199% points.

The company's Economic Capital Ratio, given in the ranking table, is -366%, being 420% points below the market average of 54%.
