The relative strengths and weaknesses of Gb Sciences INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gb Sciences INC compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 155% points. The greatest weakness of Gb Sciences INC is the variable Net Income, reducing the Economic Capital Ratio by 98% points.

The company's Economic Capital Ratio, given in the ranking table, is -26%, being 91% points below the market average of 64%.
