The relative strengths and weaknesses of Blue Dolphin Energy Co are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Blue Dolphin Energy Co compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 204% points. The greatest weakness of Blue Dolphin Energy Co is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 229% points.

The company's Economic Capital Ratio, given in the ranking table, is -35%, being 61% points below the market average of 26%.
