The greatest strength of Tianci International Inc compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 344% points. The greatest weakness of Tianci International Inc is the variable Net Income, reducing the Economic Capital Ratio by 194% points.

The company's Economic Capital Ratio, given in the ranking table, is -370%, being 458% points below the market average of 88%.
