The relative strengths and weaknesses of Genprex Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Genprex Inc. compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 213% points. The greatest weakness of Genprex Inc. is the variable Assets, Current, reducing the Economic Capital Ratio by 246% points.

The company's Economic Capital Ratio, given in the ranking table, is -247%, being 292% points below the market average of 46%.
