

The relative strengths and weaknesses of Greater Cannabis Company Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Greater Cannabis Company Inc. compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 152% points. The greatest weakness of Greater Cannabis Company Inc. is the variable Assets, Current, reducing the Economic Capital Ratio by 323% points.

The company's Economic Capital Ratio, given in the ranking table, is -448%, being 495% points below the market average of 47%.
