

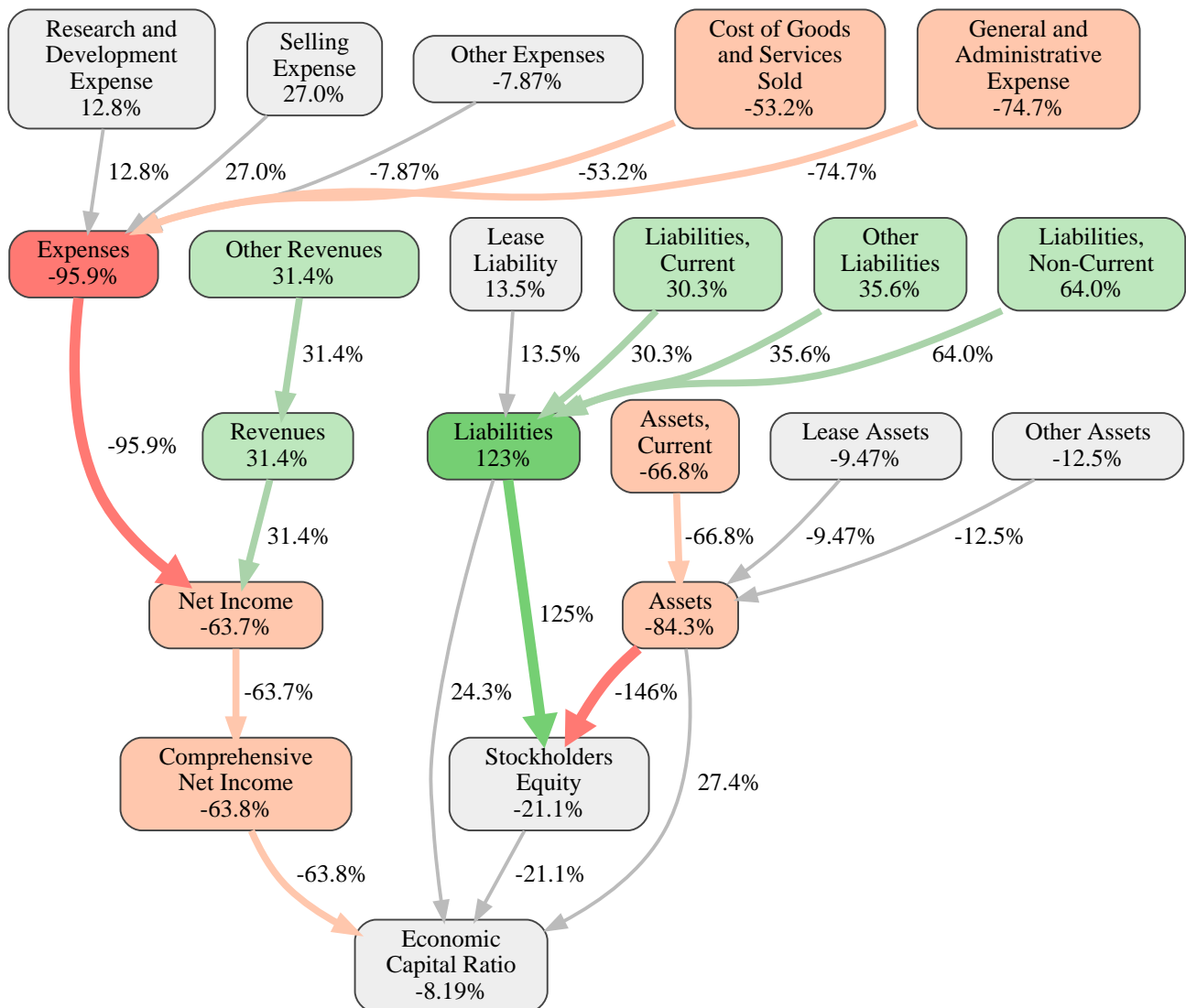

The relative strengths and weaknesses of Nixxy Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Nixxy Inc compared to the market average is the variable Liabilities, Non-Current, increasing the Economic Capital Ratio by 64% points. The greatest weakness of Nixxy Inc is the variable Expenses, reducing the Economic Capital Ratio by 96% points.

The company's Economic Capital Ratio, given in the ranking table, is 117%, being 8.2% points below the market average of 125%.
