The greatest strength of BCB BANCORP INC compared to the market average is the variable Loans, increasing the Economic Capital Ratio by 24% points. The greatest weakness of BCB BANCORP INC is the variable Deposits, reducing the Economic Capital Ratio by 22% points.

The company's Economic Capital Ratio, given in the ranking table, is 5.5%, being 5.7% points below the market average of 11%.
