The greatest strength of Microchip Technology INC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 132% points. The greatest weakness of Microchip Technology INC is the variable Liabilities, Current, reducing the Economic Capital Ratio by 37% points.

The company's Economic Capital Ratio, given in the ranking table, is 407%, being 250% points above the market average of 157%.
