The relative strengths and weaknesses of MiX Telematics Ltd are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MiX Telematics Ltd compared to the market average is the variable Liabilities, increasing the Economic Capital Ratio by 139% points. The greatest weakness of MiX Telematics Ltd is the variable General and Administrative Exp., reducing the Economic Capital Ratio by 20% points.

The company's Economic Capital Ratio, given in the ranking table, is 498%, being 144% points above the market average of 354%.
