

The relative strengths and weaknesses of Community West Bancshares are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Community West Bancshares compared to the market average is the variable Loans and Leases Receivable, increasing the Economic Capital Ratio by 17% points. The greatest weakness of Community West Bancshares is the variable Assets and Securities, reducing the Economic Capital Ratio by 8.2% points.

The company's Economic Capital Ratio, given in the ranking table, is 9.7%, being 2.0% points above the market average of 7.7%.
