The greatest strength of Agri Fintech Holdings INC compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 140% points. The greatest weakness of Agri Fintech Holdings INC is the variable Liabilities, Current, reducing the Economic Capital Ratio by 49% points.

The company's Economic Capital Ratio, given in the ranking table, is 0.44%, being 58% points above the market average of -58%.
