



The relative strengths and weaknesses of Tropicana Entertainment Inc are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Tropicana Entertainment Inc compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 191% points. The greatest weakness of Tropicana Entertainment Inc is the variable General and Administrative Expense, reducing the Economic Capital Ratio by 35% points.

The company's Economic Capital Ratio, given in the ranking table, is 258%, being 223% points above the market average of 35%.
