

The relative strengths and weaknesses of Mewbourne Energy Partners 02 A LP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mewbourne Energy Partners 02 A LP compared to the market average is the variable Liabilities, increasing the Economic Capital Ratio by 106% points. The greatest weakness of Mewbourne Energy Partners 02 A LP is the variable Oil and Gas Property, reducing the Economic Capital Ratio by 41% points.

The company's Economic Capital Ratio, given in the ranking table, is 278%, being 145% points above the market average of 133%.
