

Ultra Petroleum CORP Rank 91 of 102

The relative strengths and weaknesses of Ultra Petroleum CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ultra Petroleum CORP compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 10% points. The greatest weakness of Ultra Petroleum CORP is the variable Long-term Debt, reducing the Economic Capital Ratio by 1,409% points.

The company's Economic Capital Ratio, given in the ranking table, is 10%, being 93% points below the market average of 103%.
