The relative strengths and weaknesses of Access National CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Access National CORP compared to the market average is the variable Loans, increasing the Economic Capital Ratio by 5.5% points. The greatest weakness of Access National CORP is the variable Deposits, reducing the Economic Capital Ratio by 8.3% points.

The company's Economic Capital Ratio, given in the ranking table, is 13%, being 3.5% points below the market average of 17%.
