

The relative strengths and weaknesses of NETSOL TECHNOLOGIES INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of NETSOL TECHNOLOGIES INC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 311% points. The greatest weakness of NETSOL TECHNOLOGIES INC is the variable General and Administrative Exp., reducing the Economic Capital Ratio by 47% points.

The company's Economic Capital Ratio, given in the ranking table, is 394%, being 656% points above the market average of -262%.
