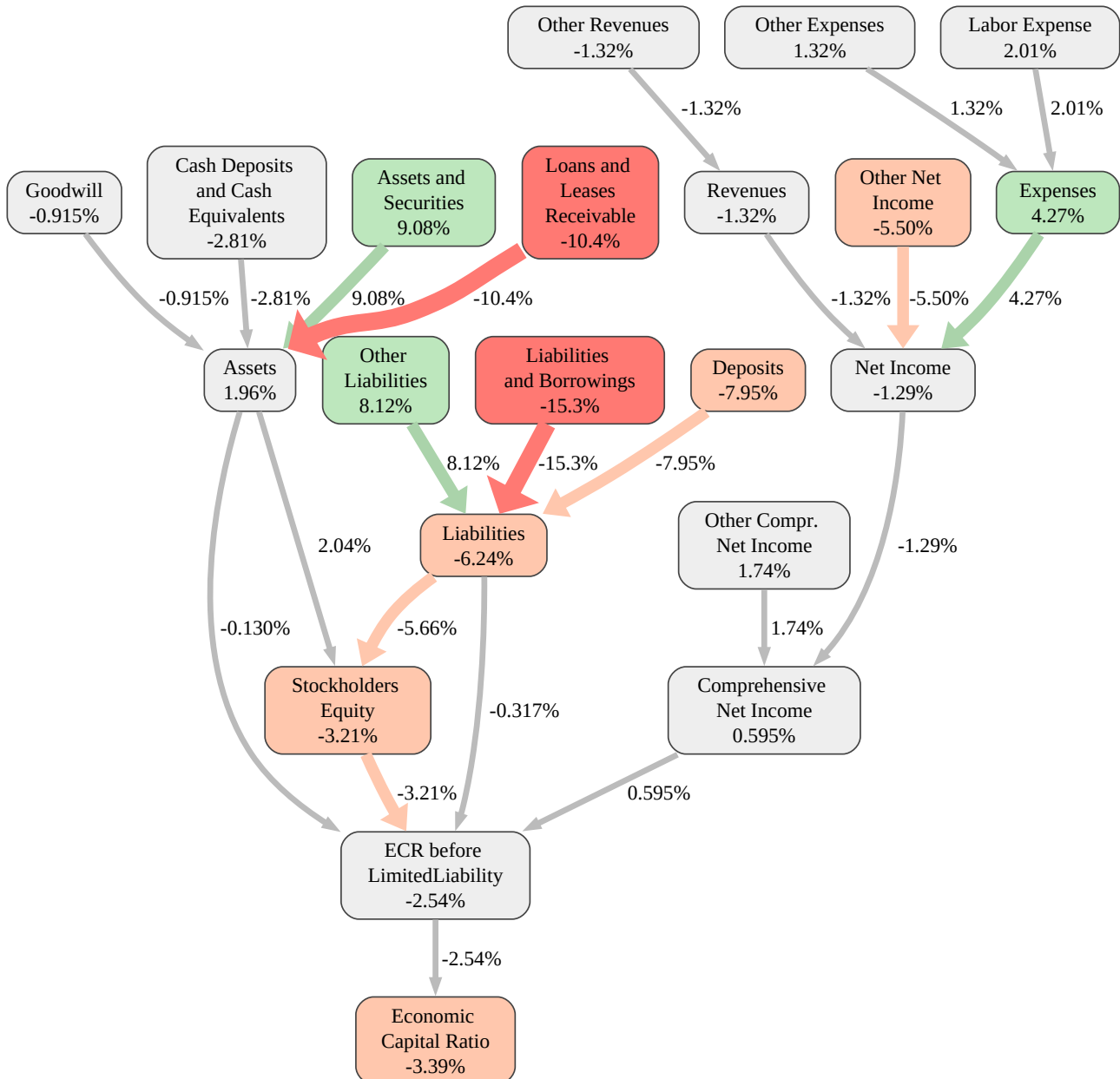






## STATE BANKS 2024

GLEN Burnie Bancorp  
Rank 116 of 134



The relative strengths and weaknesses of GLEN Burnie Bancorp are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GLEN Burnie Bancorp compared to the market average is the variable Assets and Securities, increasing the Economic Capital Ratio by 9.1% points. The greatest weakness of GLEN Burnie Bancorp is the variable Liabilities and Borrowings, reducing the Economic Capital Ratio by 15% points.

The company's Economic Capital Ratio, given in the ranking table, is 9.1%, being 3.4% points below the market average of 12%.
